#### **Chronic Disease Risk Reduction Community Grant**

The mission of the KDHE [Chronic Disease Risk Reduction \(CDRR\) community grant program](#) is to address chronic disease risk reduction through evidence-based strategies that impact commercial tobacco use, physical activity, and nutrition.

- The CDRR grant is operated under KDHE's Aid to Local grant program. It is a competitive grant awarded annually. The project period for this award is July 1 through June 30. It is the same timeline every year.
- The State Fiscal Year 2027 Request for Proposal (RFP), supplemental documents, and approximately 30-minute overview video will be available on January 15, 2026, on the KDHE Kansas Grant Management System [here](#). (Click on the Aid to Local tab, and then the CDRR tab on the left side.) The RFP and video outline eligibility, requirements, and funding restrictions.
- The grant application deadline is set by KDHE Aid to Local and is due on Monday, March 16, 2026, at noon.

### **Public comment on the PRAMS program is requested:**

Pregnancy Risk Assessment Monitoring System (PRAMS). PRAMS is a project of the Centers for Disease Control and Prevention (CDC) and health departments that collect jurisdiction-specific, population-based data on maternal attitudes and experiences before, during, and shortly after pregnancy. Current funding ends in April of 2026. An invitation to apply for a funding extension through April 2027 was received; however, this funding extension is not guaranteed. Public comments are requested to demonstrate the need for this program. Private Individuals can provide a public comment, or a comment may be made on behalf of your agency if approval is given by your agency.
